3. The alternate source of pyrethrins, Pyrethrin Extract @54%, is not currently acceptable under this registration; since the percent by weight differs, an alternate formulation would be required adjusting the percentages of the other ingredients in column 13.b on the CSF to total 100 percent.

1) Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).

2) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Extinguish all flames and pilot lights. Do not use sprayer in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.

3) Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper, paper towels or plastic tarp.

4) SHAKE CAN WELL. Break off and remove tab on side of sprayer. Tilt sprayer AWAY from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place.

- 5) Set fogger on covered stand. Immediately leave treated area.
- 6) Keep treated area closed for at least two hours. Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes.

STORAGE AND DISPOSAL

STORAGE: Store away from heat or open flames in an area inaccessible to children.

DISPOSAL: Do not reuse empty container. Wrap container and put in trash. Do not puncture or incinerate.

DESCRIPTION OF PRODUCT:

This product can also be sold with a Spray & Fog actuator, which has a special actuator that allows a portion of the product to be sprayed while holding the container inverted and the remainder of the product to be fogged. This product allows pre-treatment of heavily infested areas before fogging. Following are the 'directions for use' for the Spray & Fog. The remainder of the label is the same as above.

**PRO-CONTROL

SHAKE WELL BEFORE USE.

The 2-way system to spot spray and then fog for complete insect control.

One can will spot spray and fog a room of up to 25' X 25' X 8' of space. Use half the can for spot spraying and half the can for fogging.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Preparation and Directions for Using Container:

1) Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).

2) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Extinguish all flames and pilot lights. Do not use sprayer in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.

3) Spot spray tough insect areas: Spot spray hard to reach areas where insects tend to hide, such as in cabinets, under appliances, in corners, over carpets and other infested areas.

- * Shake can.
- * To spot spray, hold can upside down and press SPRAY button on side of sprayer.
- * After spot spraying follow fogging directions below.

4) Then fog the room:

- * Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper, paper towels or plastic tarp.
- * SHAKE CAN WELL. Tilt sprayer AWAY from face (container sprays straight up).
- * Press FOG button on side of sprayer all the way until it locks into place.
- * Set fogger on covered stand. Immediately leave treated area. Keep treated area closed for at least two hours. Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes.
