STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Flush eyes and under eyelids with plenty of water for at least 15 minutes. Call a physician immediately.

DANGER

Causes severe eye and skin damage. Do not get in eyes or on skin or clothing. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed. Avoid contamination of food.

ENVIRONMENTAL HAZARDS:

This product is toxic to fish. Do not discharge effluent containing this active ingredient into lakes, streams, ponds, estuaries, oceans, or public waters unless this product is specifically identified and addressed in an NPDES permit. FOUR WAY DISINFECTANT is a cleaner, disinfectant, and sanitizer designed for institutional use such as hospitals, nursing homes and institutions where housekeeping will be of prime importance in controlling the hazard of cross-infection from environmental surfaces. **FOUR WAY DISINFECTANT** can provide the assurance you need in this area, when used as directed. For use on floors, walls, sink tops, garbage pails, telephones, rest rooms, bed pans and operating rooms. Effective against *Staphylococcus aureus*, *Salmonella choleraesuis*, and *Pseudomonas aeruginosa*. Also effective against pathogenic fungi, *Trichophyton interdigitale*.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its label.
Disinfection: Use 2 ounces per gallon for a minimum contact time of 10 minutes. This product will be effective against *Pseudomonas aeruginosa* PRD-10 at this level.

This has been substantiated by the AOAC Use Dilution Confirmation Test. At this level, the product is fungicidal against pathogenic fungi.

For best results, use **FOUR WAY DISINFECTANT** with a cloth or mop and apply to walls, floors and other hard surfaces.

For heavy soil or organic matter, a pre-cleaning step is recommended.

Sanitization: Use **FOUR WAY DISINFECTANT** for sanitization of previously cleaned food equipment or food contact items. Apply a solution containing 2.8 ounces of **FOUR WAY DISINFECTANT** in 5 gallons of water (200 ppm of active quaternary) for a minimum contact time of 1 minute. Sanitizing solution can be applied by mop, cloth, immersion or spraying being certain to wet all surfaces thoroughly. Drain solution from surface and allow to air dry. **NO POTABLE WATER RINSE IS REQUIRED.**

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a dry place no lower in temperature than 50°F or higher than 120°F.

CONTAINER DISPOSAL: Do not reuse empty containers. Triple rinse empty containers with water, then offer for reconditioning or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities. Plastic containers may not be disposed of in a sanitary landfill, incinerated, or if allowed by local authorities, by burning, stay out of smoke.
