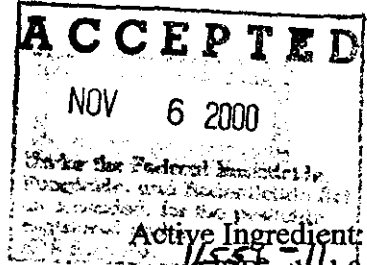

PRECAUTIONARY STATEMENTS / PRACTICAL TREATMENT

Fatal if swallowed. May be fatal if inhaled. Do not breathe vapors. Do not get in eyes, on skin or clothing.

If swallowed - Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching the back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious person.

- If on skin - Remove contaminated clothing and wash affected areas with soap and water.
- If in eyes - Flush eyes with plenty of water. Call a physician immediately.
- To physician - Atropine sulfate by injection is antidotal. Repeat as necessary to the point of tolerance. 2-PAM is also antidotal and may be administered in conjunction with atropine.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to birds, fish and aquatic invertebrates. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless this product is specifically identified and addressed in a NPDES Permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance, contact your State Water Board or Regional Office of the EPA.

STORAGE AND DISPOSAL
