



#### DIRECTIONS FOR USE

**IMPORTANT:** Read Directions, including the Warranty and Limitation of Damages, before using this product. Shake well before using. Open nozzle by turning tip up. Keep nozzle tip closed (down) when not in use. Squeeze container to expel dust in short, light clouds. Hold nozzle 2 to 4 inches from area to be treated and apply light, even coat on and around this area.

**RECOMMENDED APPLICATIONS & RESTRICTIONS**  
**SCREW-WORMS:** Treat infested wounds with light but thorough coverage. Be sure all parts of wound are completely coated. New wounds from docking, dehorning, etc., should be dusted at once with light uniform coat to avoid infestation. Repeat as necessary. **EAR TICKS:** Dust into the ear and also treat the adjacent head area. Use short, sharp pressure on container. Repeat as necessary.

No interval is required between treatment and use of meat or milk as food.

For external, insecticidal use on animals only. Avoid contamination of feed, water, and water utensils.

#### WARNING

Provide thorough ventilation while dusting. Avoid prolonged inhalation of dust. Harmful if inhaled or absorbed through the skin. Avoid contact with skin or eyes. Wash after handling. Do not contaminate feed or food. Keep out of reach of children. If poisoning occurs, obtain prompt medical aid.

**To Physician—**Prolonged exposure will result in cholinesterase depression. Atropine sulfate is antidotal.
