For treatment of wounds infested with screw-worms and fly maggots, spray wounds until complete coverage is obtained. Repeat as necessary.

For prevention, spray a protective coating on new wounds from dehorning, castration, docking, injury, etc. as soon as possible to avoid infestation. Repeat as necessary.
