Your Letter Dated September 10, 1990 and Your Revised Labels Received April 4, 1991

The amendment referred to above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), is acceptable provided that you:

- 1. Submit/cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregisteation of your product under FIFRA section 4.
- 2. For <u>all</u> above listed products make the following label revisions:
 - a. Under the "To Physician", revise the statement to read: "Atropine sulfate by injection is antidotal."
 - 3. For EPA Reg. No 11556-23, make the following changes:
 - a. Add a footnote in the ingredient statement indicating: *Contains aromatic petroleum distillates."
- b. The complete Statement of Practical Treatment must appear on the front panel of the label for all pesticides that fall into Toxicity Category I on the basis of officuration and dermal toxicity.

- c. Add the following sentence ...der Use Restrictions:

 For external insecticidal use only on abovespecified animals.
- 4. For EPA Reg. No. 11556-25, make the following changes:
 - a. Under the Statement of Practical Treatment, add the sentence, "If possible, vomiting should be induced under medical supervision.", before the "Drink one or two glasses of water...".
 - b. Add the following sentence under Use Restrictions:
 For external insecticidal use only on above-specified animals.
- 5. For EPA Reg. No. 11556-40, make the following changes:
 - a. Delete the statement, "This product contains the toxic inert ingredient, methylene chloride.", from the ingredient statement since this inert is no longer a part of the formulation.
 - b. Change 130°C to 130°F under the Storage and Disposal Statement.
 - c. Also under Storage and Disposal, add the statement, "Do not contaminate water, food or feed by storage and disposal.
 - d. Add the following statement under Use Restrictions:
 Do not apply to sick, stress or convalescent livestock or to animals less than 3 months of age.
- 6. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.
- 7. The revised Confidential Statement of Formulas (CSFs) referred to above, submitted in connection with registration under Federal Insecticide, Fungicide, and Rodenvicide Act, as amended, are acceptable. A copy of each have been inserted in your file for the subject products.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

SCREWWORMS AND FLY MAGGOTS ON BEEF AND DAIRY CATTLE, SHEEP, GOATS, SWINE AND HORSES: Hold spray nozzle 3 to 10 inches from the wound area to be treated and apply a protective coating on and around the wound.

For the <u>treatment</u> of wounds infested with fly maggots and screw worms on beef and dairy cattle, sheep, goats, swine and horses, spray wounds until complete coverage is obtained. Repeat as necessary.

For prevention, spray a protective coating on new wounds from dehorning, castration, docking, injury, etc. as soon as possible to avoid infestation. Repeat as necessary.

EAR TICKS ON BEEF AND DAIRY CATTLE: For control, spray directly into each ear canal until complete coverage is obtained (approximately 5 seconds). Repeat as necessary.

No interval is required between treatment of beef and dairy cattle and swine and use of meat or milk as food.

Do not treat sheep and goats within 3 days of treatment and slaughtering.
