Kills Screw Worms (*Cochliomyia hominivorax*) and other common wound maggots (*Cochliomyia macellaria*) (*Lucilia sericata*) and (*Phormia regina*). Protects wounds against reinfestation with these parasites for reasonable time. Will not rub off, melt off in the sun, or wash off in the rain.

DIRECTIONS

1. Shake can. Point arrow on nozzle toward animal.
2. Hold can upright 4" to 6" from affected area and press down on spray nozzle.
(If nozzle should clog, pull off spray head and clean by passing a fine wire through the opening.)

TREATMENT AND PREVENTION

Spray K-R-S directly into superficial wounds and cuts to kill screw worms or other common wound maggots, and for an inch or so around the wound to prevent further attacks. Repeat as necessary to keep the wound protected until healed.
