Your Application Dated September 28, 1987

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Add the Precautionary Statements heading to the paragraph that has such statements.
 - b. Add the Chemical and Physical Hazards heading to the paragraph that has such statements and change "Warning" to "Caution" at the beginning of the paragraph.
 - c. Add a paragraph titled Statement of Practical Treatment, with appropriate first aid statements for every exposure route, in the following format:

- If In Eyes: . . .
- If On Skin: . . .

- d. Revise the Storage and Disposal statement per PR Notice 83-3.
2. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

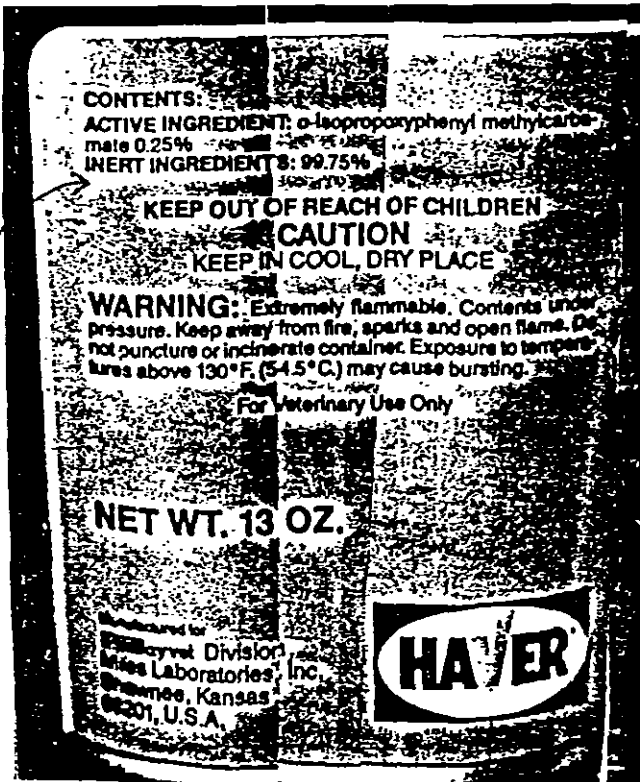
