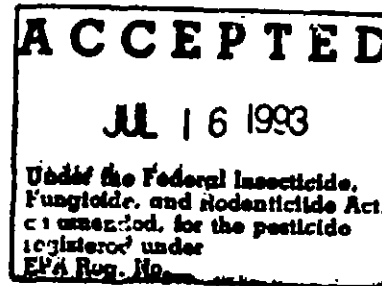

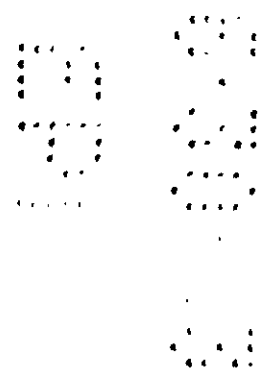

Hold the unit 6-8 inches from the skin while spraying. Cover the surface of the horse with spray. Do not apply over cuts, wounds, or irritated skin. Do not apply under the saddle. Avoid getting product into horse's eyes or other sensitive areas such as mouth or nose. Apply on face by first spraying small amounts on a soft cloth and then spreading on the face and neck. Apply a light mist sufficient to wet the surface of the hair. Saturation is unnecessary. Repeat treatment as needed.

Will not damage nylon, cotton or wool. May damage some synthetic fabrics, plastics, leather, painted or varnished surfaces.

DISPOSAL: Do not reuse empty container. Rinse thoroughly before discarding in trash.
