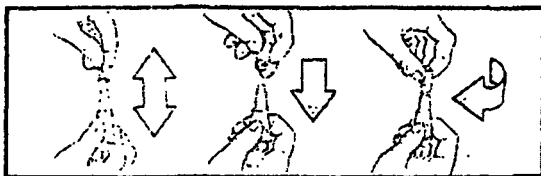

Twist cap to break seal, then remove cap from tube.
