3. Make the following labeling revisions.

a. Revise the statement "Do not use on puppies 8 weeks of age" to "Do not use on puppies under four months of age."

b. After the statement "Shampooing of the dog may shorten the duration of flea protection, therefore reapplication following shampooing is recommended." add the sentence "If re-treatment becomes necessary earlier than four weeks, do not re-treat more than once weekly."

c. Add the statements "As with any product, consult your Veterinarian before using this product on debilitated, aged, pregnant or nursing animals." and "If your animal is on medication consult your veterinarian before using this or any product." to your Hazards to Domestic Animals paragraph.

4. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

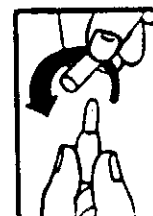

6. The dog should be standing for easy application. Part the hair on the dog's back, between the shoulder blades, until the skin is visible. Place the tip of the tube on the skin and squeeze the tube twice to apply the solution directly on the skin.

Do not get this product in your pet's eyes or mouth.



7. Discard empty tube as described in Storage and Disposal.

Advantage™ will kill 98-100% of the fleas on dogs within one day of treatment and will continue to protect the dog from further flea infestation for at least four (4) weeks. Reinfestation from the emergence of new fleas in the environment may continue to occur for six weeks or longer after treatment is initiated.

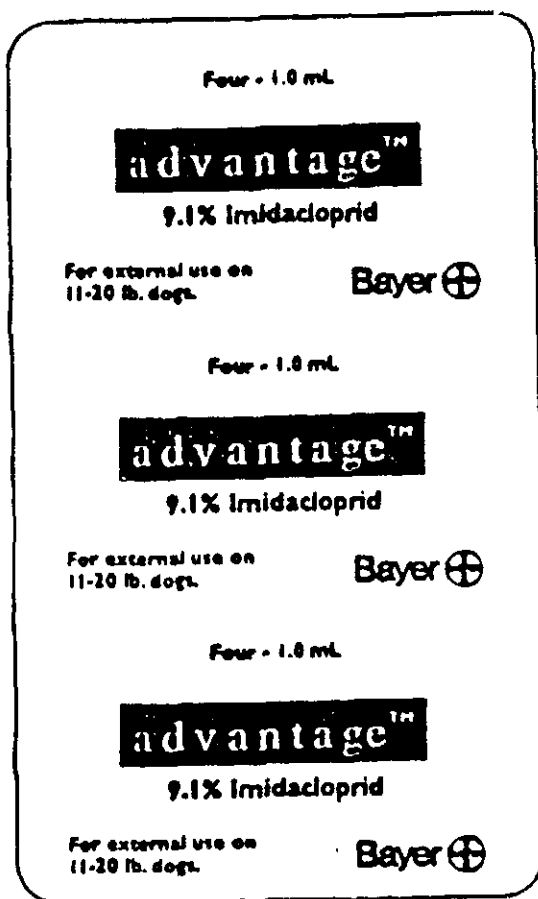
