Dear Mr. McNamara.

The subject labels have been reviewed and will be acceptable if the following claim modification is made on each of the labels. Delete "The successive feeding activities.....reduces the incidents of this condition." The following statement may be used as a replacement:

"The successive feeding activities of fleas on pets may elicit a hypersensitivity skin disorder known as flea allergy dermatitis (FAD). Treatment of pets with Advantage rapidly kills fleas and may reduce the incidence of this condition."

Two copies of each final printed label should be submitted to the Agency prior to shipment of the products. Stamped copies of the subject labels are enclosed for your files.






- 3. Hold applicator tube in an upright position. Pull cap
- 4. Turn the cap around and place other end of cap back
- The cap around and place other end of cap back on tube.

 Twist cap to break seal, then remove cap from tube.

 The dog should be standing for easy application. The entire contents of the Advantage® tube should be applied evenly to three or four spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin
