Dear Todd Frank:

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Diazinon 2022 Biological Opinion and Coumaphos Interim Decision. The Agency has concluded that your submission is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. The next label printing of this product must use this labeling unless subsequent changes have been approved by the Agency. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those

claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

RESISTANCE-MANAGEMENT RECOMMENDATIONS

For resistance management, Co-Ral Plus Insecticide Cattle Ear Tag contains Group 1B insecticides. Any insect population may contain individuals naturally resistant to Co-Ral Plus Insecticide Cattle Ear Tag and other Group 1B insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly in the same fields. Appropriate resistance-management strategies should be followed.

To delay insecticide resistance, take the following steps:

- Rotate the use of Co-Ral Plus Insecticide Cattle Ear Tag or other Group 1B insecticides, with different groups that control the same pests.
- Adopt an integrated pest management program for insecticide/acaricides use that includes scouting, uses historical information related to pesticide use, crop rotation, record keeping, and which considers cultural, biological and other chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests the presence of resistance, consult with your local university specialist or certified pest control advisor.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for the specific site and pest problems in your area.



For the control of Horn Flies (including pyrethroid-resistant Horn Flies), Gulf Coast Ticks, and Spinose Ear Ticks on beef and non-lactating dairy cattle and as an aid to control Face Flies.

All mature animals in the herd should be tagged. For adequate control of Horn Flies attach one tag per animal. For optimum control of Horn Flies, Gulf Coast Ticks, and Spinose Ear Ticks, and as an aid in the control of Face Flies, attach one tag to each ear (two per animal). Replace as necessary. Co-Ral® Plus Insecticide Ear Tags have been proven to be effective against Horn Flies for three to five months.

Use Allflex Universal Total Tagger with the red pin and black clip to apply tags to cattle.

Apply as indicated (Figures 1-4). Calves less than 3 months of age should not be tagged as ear damage may result. Remove tags at end of fly season or prior to slaughter.



Continual exposure of Horn Flies to a single class of insecticide (e.g. pyrethroids or organophosphates) may lead to the development of resistance to that class of insecticide. In order to reduce the possibility of Horn Flies developing resistance it is important to rotate the class of insecticide used and/or the method of Horn Fly control on a seasonal basis. Co-Ral® Plus Insecticide Cattle Ear Tags contain the organophosphate insecticides coumaphos and diazinon.
