Dear Ms. Hunt:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. It has come to our attention that the precautionary statements have to be upgraded based on the toxicity categories assigned to this product. Therefore revise the Precautionary Statement to read as follows:
 - "Causes substantial but temporary eye injury. Do not get in eyes or on skin nor clothing. Harmful if swallowed. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse."
- 2. Replace "Inert Ingredients" with "Other Ingredients" in the Ingredients statement.
- 3. The data submitted to support the waterproof claim appears to confirm the water repellency, however the data is incomplete. Submit to the Agency within 3 months of this letter the complete data including raw data sheets. Please see enclosed efficacy review dated August 8, 2007.

- 4. Change "waterproof" to "water repellent" throughout the labeling.
- 5. Add "To the extent consistent with applicable law" to the beginning of the sentence "Bayer makes no other express or implied warranty ... etc" and "Any damages arising from a breach of this warranty shall be limited etc." in the Limited Warranty statement.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.




1. Use only on dogs. DO NOT USE ON CATS or on other animals.

2. Remove applicator tube from the package.



- 3. Hold applicator tube in an upright position. Pull cap off tube.
- 4. Turn the cap around and place other end of cap back on tube.
- 5. Twist cap to break seal, then remove cap from tube.
- 6. The dog should be standing for easy application. Part the hair on the dog's back, between the shoulder blades, until the skin is visible. Place the tip of the tube on the skin and squeeze the tube twice to expel the entire contents directly on the skin.



Do not get this product in your dog's eyes or mouth.

7. Discard empty tube as described in Storage and Disposal.
