- 4. Repeat steps 1 to 3 for each tube.

- 1.Be sure tube is at bottom of pouch.
- 2. Using scissors, cut the pouch across the top and remove tube.




- 3. Turn the cap around and place other end of cap back on tube.
 - 4. Twist cap to break seal, then remove cap from tube.
 - 5. The dog should be dry and standing for easy application. The entire contents of the K9 Advantix® tube should be applied evenly to three or four spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin and gently squeeze to expel a portion of the solution on the skin.
