- Available only through licensed practicing veterinarians
- Repels and kills ticks including Deer ticks (vector of Lyme disease), American dog ticks (vector of Rocky Mountain spotted fever), Brown dog ticks (vector of ehrlichiosis), and Lone Star ticks for up to four weeks
- Kills 98-100% of the fleas on dogs within 12 hours and continues to prevent infestations for at least four weeks

Directions for Use

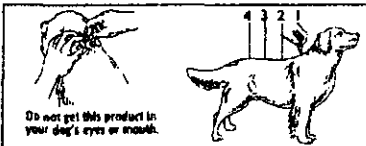
It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Do not contaminate feed or food.

How to Apply

1. Use only on dogs. DO NOT USE ON CATS or on other animals.
2. Remove applicator tube from the package.



3. Hold applicator tube in an upright position. Pull cap off tube.
4. Turn the cap around and place other end of cap back on tube.
5. Twist cap to break seal, then remove cap from tube.
6. The dog should be standing for easy application. The entire contents of the K9 Advantix[®] tube should be applied evenly to three or four spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin and gently squeeze to expel a portion of the solution on the skin. Do not apply an excessive amount of solution at any one spot that could cause some of the solution to run off the side of the dog.



7. Discard empty tube as described in Storage and Disposal.

Kills fleas which may cause flea allergy dermatitis (FAD).

K9 Advantix kills 98-100% of the existing fleas on dogs within 12 hours. Reinfesting fleas are killed within 2 hours with protection against further flea infestation lasting at least four (4) weeks. Pre-existing pupae in the environment may continue to emerge for six (6) weeks or longer depending upon the climatic conditions.

Larval flea stages in the dog's surroundings are killed following contact with a K9 Advantix treated dog.

K9 Advantix remains efficacious following a shampoo treatment, swimming or after exposure to rain or sunlight.

Monthly treatments are required for optimal control and prevention of fleas and ticks.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool, dry place. Protect from freezing.

Pesticide Disposal:

If empty: Do not reuse this container. Place in trash or offer for recycling if available.
