#### FIRST AID


#### **HOW TO APPLY**

- 1. Use only on dogs. DO NOT USE ON CATS or on other animals.
- 2. Remove applicator tube from the package. Use scissors and peel down foil.



- 3. Hold applicator tube in an upright position. Pull cap off tube.
- 4. Turn the cap around and place other end of cap back on tube.
- 5. Twist cap to break seal, then remove cap from tube.
- 6. The dog should be standing for easy application. The entire contents of the K9 Advantix® Plus tube should be applied evenly to two to three spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin and gently squeeze to expel a portion of the solution on the skin. Do not apply an excessive amount of solution at any one spot that could cause some of the solution to run off the side of the dog.

K9 Advantix<sup>®</sup> Plus 10 kills existing fleas on dogs within 12 hours. Reinfesting fleas are killed within 2 hours with protection against further flea infestation lasting at least four (4) weeks. Pre-existing pupae in the environment may continue to emerge for six (6) weeks or longer depending upon the climatic conditions.

Larval flea stages in the dog's surroundings are killed following contact with a K9 Advantix<sup>®</sup> Plus 10 treated dog.

K9 Advantix<sup>®</sup> Plus 10 is waterproof and remains effective following a shampoo treatment, swimming or after exposure to rain or sunlight.

Monthly treatments are required for optimal control and prevention of fleas and ticks.

If re-treatment becomes necessary, do not re-treat more than once every week.

#### STORAGE AND DISPOSAL
