
- 1. Being careful not to cut close to the blister cavities, take scissors and cut off one section of the card containing a single tube.
- 2. Take the separated section, and cut into the blister cavity across the small side, close to the cap of the tube.
- 3. Peel off the foil, and take out the tube.
- 4. Repeat steps 1 to 3 for each tube.



HOW TO APPLY

- Use only on dogs. DO NOT USE ON CATS or on other animals. 1.
- 2. Remove applicator tube from the package. Use scissors and peel down foil.



- 3. Hold applicator tube in an upright position. Pull cap off tube.
- 4. Turn the cap around and place other end of cap back on tube.
- 5. Twist cap to break seal, then remove cap from tube.
- 6. The dog should be standing for easy application. The entire contents of the K9 Advantix® Plus tube should be applied evenly to four to six spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin and gently squeeze to expel a portion of the solution on the skin. Do not apply an excessive amount of solution at any one spot that could cause some of the solution to run off the side of the dog.
