- b. Delete all references to fast acting, long lasting fast knockdown and residual control claims throughout the labeling and optional marketing claims. These claims do not appear on the cited products. Data needs to be submitted or cited to support such claims.
- c. Under "where to use" on the blister card and leaflet identify the specific sites of application i.e. "... as perimeter treatment in and around barns, horse stable and other animals quarters.".
- d. Under "Where to Use" on the blister card and leaflet add a reapplication interval i.e. "Reapply in 7-10 days as needed.".
- e. Under General Information delete "but are not limited to", "ant hills" and "dog houses". The specific sites of application are identified on the label. "Ant hills" is an unqualified application site. Dog houses implies use around residential areas.

In the same section add the following site limitations: "Not for use in and around residential areas.". "Do not use in commercial food/feed handling establishments, restaurants or other areas where food is commercial prepared, processed or served."

- f. Delete "but not limited to" under Indoor Pest Control. See item (e) above for explanation.
- g. Under General Surface Application delete the section beginning "All food processing surfaces and utensils... and ending 10- day interval (if necessary).". These comments pertain to use in food/feed handling establishments.
- h. Under Spot Crack or Crevice Applications delete "refrigerators", "stoves" and the entire last paragraph beginning, "For the control of exposed adult and immature stages...etc.". These comments pertain to use in residential and/or commercial food handling establishments.
- i. Delete the entire list of indoor pests under item 3., Pantry and Stored Panty Pests. This is a list of pests found in residential or commercial food handling establishments and not livestock housing areas.
 - j. Change "kills on contact" to "kills by contact".
- k. Under Outdoor Pest Control qualify the beginning of the sentence on fire ants to read, "For the control of the imported red fire ant around the sites listed above mix... etc.".

- 1. Delete the following bullets under Alternate Marketing Claims: "Low odor formula; field and laboratory tested; Proven results; Powerful results, small bottle; Small but mighty; Small bottle, powerful results; "barrier", "stops" and Use what the professionals use". Words or phrases implying that a product possess a unique characteristic because of the composition and packaging or words implying misleading comparisons to other pesticides are not acceptable. Likewise words or phrases implying complete control or eradication of pests are not acceptable.
- m. Under General Information add "Do not use food utensils such as teaspoons or measuring cup for food purposes after use with insecticides.".
- n. In the warranty statement add the phrase "To the extent permitted by applicable law" to the beginning of the sentence "Bayer offers and the buyer accepts and uses... etc.".
- o. Update the container disposal statement in accordance with PR $_{\mbox{\scriptsize Notice}}$ 2007-4.
- 3. In your October 22, 2007 letter you indicated that this product is 100% repack of 11556-124. Therefore correct the confidential statement of Formula to reflect this registration number.
- 4. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

GENERAL INFORMATION

Tempo SC Ultra Pest Control Concentrate [is a liquid formulation containing 1 lb active ingredient per gallon which] will provide effective knockdown and residual control of the pests listed on this label.

Tempo SC Ultra Pest Concentrate is intended for use as a general surface, spot, or crack and crevice [spray] [application] in and around buildings and structures and their immediate surroundings. Permitted areas of use include, **but are not limited to**: animal runs, animal holding areas, animal quarters, ant hills, boarding kennels, chicken houses (when birds are not present), dairy barns, dog houses, feed lots, horse stables, kennels, livestock [pigs, cattle, sheep, goat] barns and holding facilities, storage areas, storage rooms, trailers, turkey houses, utility rooms, and rooms in animal facilities.

Cleaning of all areas prior to use of Tempo SC Ultra Pest Control Concentrate will increase levels of control. Any foodstuffs infested with pests should be removed and destroyed.

MIXING INSTRUCTIONS

Tempo SC Ultra Pest Control Concentrate is intended to be mixed with water and applied with pump style sprayer or trigger spray bottle. Add the appropriate amount of product while filling the sprayer with water, and shake to mix. Use [(1 Tablespoon) (16 milliliters)] [of Tempo SC Ultra Pest Control Concentrate] [one half of the bottle's contents] per 1,000 ft² in [(sufficient water) (1 gallon of water)] [a 0.05% concentration] to adequately cover the area being treated, but which will not allow dripping or run off to occur. INDOOR PEST CONTROL

For use in animal housing, including, but not limited to livestock barns, horse stables, and other animal quarters to control crawling and flying insect pests. Apply diluted spray as a general surface and/or a crack and crevice spray. Control will be enhanced when facilities are cleaned and interior applications are supplemented with exterior perimeter treatments. Do not make interior applications of Tempo SC Ultra Pest Control Concentrate in areas of facility where animals are present. Do not make applications to animal feedstuffs or watering equipment.

GENERAL SURFACE APPLICATIONS

For general pests, occasional invaders, and flying insects apply the diluted spray evenly to walls, floors, between, behind and beneath equipment, appliances, around floor drains, window and door frames, and on the underside of shelves, drawers and in similar areas. Applications may be made to floor surfaces along walls and around air ducts; however do not treat the entire area or floor or floor coverings. Pay particular attention to treating entry points and harborage areas. All food processing surfaces and utensils should be covered or thoroughly washed following treatment. Cover exposed foodstuffs or remove from area being treated. [Reapplication can be made at 10-day intervals (if necessary)]. Do not apply where electrical short circuits could occur. Use a dust or dry bait in these areas. It is recommended to wear safety glasses, goggles or face shield and a respirator when making a general surface treatment to overhead areas. For control of flying insects, make application to surfaces or directly where the pest collects or rests. Do not apply as a ["space spray"] [aerial spray or mist] [fog].

SPOT, CRACK OR CREVICE APPLICATIONS

Use low spray pressure and pin-point application in specific areas such as: cracks and crevices in or behind baseboards, in floors, walls, expansion joints, areas around water and sewer pipes, wall voids, or voids in table legs and equipment where pests can hide, storage areas, closets, around water pipes, doors and windows, behind and under refrigerators, cabinets, sinks, stoves and other equipment, the underside of shelves, drawers, as well as other similar areas. Do not apply where electrical short circuits could occur. Use a dust or dry bait in these areas.

For control of exposed adult and immature stages of **pantry and stored product pests**, apply diluted spray to cupboards, shelving and storage areas. Particular attention should be given to treating cracks and crevices and other surfaces where the pests have been seen or found. Remove all utensils, uncovered foodstuffs or any open packages, shelf

paper and other objects before spraying. Allow treated surfaces to dry and cover shelves with clean paper before replacing any utensils, foodstuff or other items. Any foodstuff accidentally contaminated with the diluted spray should be discarded.

OUTDOOR PEST CONTROL

For control of flying insects outdoors: Make applications to outside surfaces of barns, horse stables, animal confinement areas, animal quarters, buildings, feedlots, animal holding areas, storage areas, workshops, and other areas where these pests have been seen or found. Make pin stream applications directly to the nests of wasps, yellow-jackets and hornets. For perimeter pest control, make a general surface application to outside surfaces of barns, horse stables, animal confinement areas, animal quarters, buildings, feedlots, animal holding areas, storage areas, workshops, and other areas where pests have been seen or found. To help prevent infestations of buildings by occasional invaders, treat soil, mulch, turf or other substrates adjacent to buildings, the building foundation, walls, around doors and windows, soffit areas where these pests are active and may find entrance.

For control of the **imported red fire ant,** mix Tempo SC Ultra Pest Control Concentrate as directed above and thoroughly drench or inject the entire mound area. Treat all areas of the mound showing activity to provide contact control of the adult fire ants. Tempo SC Ultra Pest Control Concentrate will provide contact activity and residual control in the active mound.

CONTROL OF WOOD INFESTING PESTS

Make a diluted spray by mixing [(1 Tablespoon) (16 milliliters)] of Tempo SC Ultra Pest Control Concentrate in one gallon of water [(a 0.05% concentration)].

For control of **wood infesting beetles** on structure surfaces) apply diluted spray to thoroughly and evenly cover the area. If spraying overhead, cover all surfaces below the area being sprayed with plastic sheeting or other material which can be disposed of by placing in trash if contamination from dripping occurs. Sprayed surfaces should be avoided until the treated area is completely dry.

For control of **above ground termites and wood-infesting beetles** in localized areas, apply diluted spray to voids and galleries in damaged wood, and in spaces between wooden structural members and between the sill plate and foundation where wood is vulnerable.

Such applications for termites are not a substitute for mechanical alternation, soil treatment or foundation treatment, but are merely a supplement. For active termite infestations, get a professional inspection.
