Insecticide Resistance Management

For resistance management, Conquest Insecticide contains a Group 5 insecticide. Any insect population may contain individuals naturally resistant to Conquest Insecticide and other Group 5 insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly. Appropriate resistance-management strategies should be followed.

To delay insecticide resistance, take the following steps:

- Rotate the use of Conquest Insecticide or other Group 5 insecticides with different groups that control the same pests.
- Adopt an integrated pest management program for insecticide use that includes scouting, uses historical information related to pesticide use, record keeping, and which considers cultural, biological and other chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests the presence of resistance, consult with your local university specialist or certified pest control advisor.

Poultry Houses: Darkling Beetles (Alphitobius diaperinus)

Do not exceed an application rate of 2 kg [product] [Conquest Insecticide] [tablets] (0.022 lbs active ingredient) per 20,000 square foot poultry house. Apply once per flock.
