DIRECTIONS FOR USE
For Spot Application Only

- ✓ **General:** Chlorpyrifos with synergized d-trans[®] Allethrin insecticide used as a spot treatment to control cockroaches, silverfish, spiders and other pests specified below. Spray localized areas where pests may occur. Spray surfaces until wet. Re-treat as needed.
- ✓ **To Kill Cockroaches, Ants, Crickets, Silverfish, Spiders, Sawbugs:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and doors and frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat as necessary.
- ✓ **To Kill Brown Dog Ticks and Fleas:** Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.
- ✓ **Flies and Mosquitoes:** Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home.
- ✓ **Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when necessary.**
- ✓ **Flammable!** Contents under pressure. Do not use or store near fire, sparks or flame. Exposure to temperatures above 120°F may cause bursting. Never throw container into fire or incinerator.
- ✓ **Harmful if swallowed. Avoid contact with skin, eyes, or clothing. Avoid breathing of spray mist, or vapors. If swallowed do not induce vomiting, call a physician immediately. In case of contact with eyes, flush with plenty of water and get medical attention.**
- ✓ **Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food processing is exposed. Do not store near or contaminate food or foodstuffs.**
- ✓ **Remove pets and cover fish bowls before spraying. This product is toxic to fish, birds, and other wildlife. Keep out of lakes, streams, or ponds.**
- ✓ **Note to Physician:** Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.
- ✓ **Do not spray in or on room or use on plants. Apply as a surface spray only as specified on this label.**
- ✓ **Do not allow children or pets to contact treated surfaces until spray has dried.**

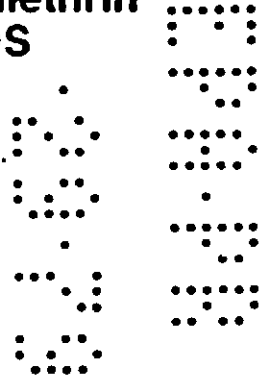
