2. Based on the acute toxicology profile of this product your may remove the statements "Causes moderate eye irritation. Avoid contact with eyes, skin, or clothing. Avoid breathing dust. Remove contaminated clothing and wash before reuse." from your Precautionary Statements.

3. Based on the acute toxicology profile of the product you may remove the sections referring "IF In Eyes", "If on Skin or Clothing" and If Inhaled" from your first aid statements.

Submit three (3) copies of your final printed labeling. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.
