A-10 ALGAECIDE

A-10 Algaecide is used to inhibit the growth of algae, bacteria and fungi in recirculating commercial and industrial cooling water systems. Initial Dosage: Apply 24 to 48 liquid ounces of product per 1000 gallons of water (200 to 400 ppm) in the system. Repeat until control is achieved. Subsequent Dosage: When microbial control is evident, apply 12 to 24 liquid ounces of product per 1000 gallons of water (100 to 200 ppm) of water in the system every 1 to 7 days, or as needed. Add to a point of rapid circulation such as tower basin pump suction or distribution trays. Dosage frequency depends on bleed-off and retention in the system and severity of the microbial problem. Begin treatment when the system is in jeopardy of becoming affected or after cleaning system whose efficiency is already impaired.
