The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

Label Update

Conditions

The Agency has not recently reviewed an updated Confidential Statement of Formula (CSF) for this Product. Please submit a revised CSF for review at your earliest convenience.

The Active Ingredients Statement on the submitted labeling is acceptable. Your proposed labeling has been corrected to be in agreement with the original label and CSF which was registered with the Agency. Thus the corrected Ingredients Statement for this product is as follows:

Revise the label as follows:

1) Revise the statement "An Effective All Surface Disinfectant Cleaner and Deodorant" by deleting the claim "All Surface" as this is too broad in describing the use of this product. This product is for use on the surfaces identified on the label, not "all surfaces."

2) Delete the heading "General Classification" which is unnecessary. In addition, delete the heading "Directions" as your label previously states "Directions for Use."

3) Revise the directions to state: "Remove cap. Shake. To Clean: Spray evenly over surface. Wipe clean..." Also revise to state: "To Disinfect: Preclean by spraying onto surfaces and allow foam..." and add the following statement to the remaining disinfection directions: "Allow surfaces to remain wet for 10 minutes."

4) Separate the following statement from other sections on the label and place in bold: "Surfaces disinfected with this product must be rinsed with potable water before coming in contact with edible food products."

5) Delete the claims and directions for disinfection of sink drains with or without disposals. We have reevaluated this claim on your labeling. The Agency has determined that it is not feasible to disinfect throughout a drain with or without a disposal system. This product when used in this manner would tend to flow down through the drain and not necessarily remain in contact with all drains and disposal surfaces for 10 minutes. It is unlikely that this product would adequately penetrate through the buildup within the pipes/drain to disinfect the drain surfaces. This product would not be able to seep through these layers of buildup.

You may retain the statements regarding cleaning and deodorizing of these sites.

6) Your product is for disinfection of hard non porous surfaces. Delete the following from the "Used On" section, as these surfaces are not hard non-porous: "grouting," "leather," and "leatherette." Revise this section to begin: "Used On the following hard non-porous surfaces: counter tops, table tops, plastic surfaces..." also revise to state: "glazed tiles," "finished woodwork," and "glazed porcelain."

7) Your current "Precautionary Statements" do not agree with in the label review manual. Revise your "Precautionary Statements" to read as follows: "Caution: Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling."

8) Revise your "Statement of Practical Treatment" to be in agreement with PR Notice 2001-1 as follows:

"IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a

9) Revise your label such that it includes the heading "STORAGE AND DISPOSAL." and delete the separate headings for "Storage" and "Disposal."


DIRECTIONS

Remove cap. Shake. Spray evenly over surface. Wipe clean. For heavily soiled surfaces, allow foarm to remain up to a minute before wiping.

To Disinfect: Spray onto surface and allow foam to remain a short while. Then wipe clean. Then spray again; wipe gently with a clean, damp cloth. Do not dry. Surfaces cleaned and disinfected with cleaner must be rinsed with potable water before coming in contact with edible food products. Always hold the container as upright as possible when spraying.

FOR SINK DRAINS WITH OR WITHOUT DISPOSALS

Step 1: Clean & Deodorize – Shake can. For best results, run hot water into sink for 11 minutes to soften soils. Turn off water, let drain. If applicable, make sure disposal unit is empty and turned off. Spray foam into sink drain opening until it is filled with foam. Allow to remain for 10 minutes. Rinse drain with more hot water (turning on disposal unit as applicable).
