upward into center of room with slow sweeping spray in the evening or on a cloudy day when air is motion. Spray 5-10 seconds for average room keep still. Mist the plants lightly. Use a slow sweeping room closed for 15 minutes after spraying. Sweep up motion. Avoid wetting follage with spray. Spray rows and destroy fallen insects. Before spraying cover at a rate of 1 tool per second. For heavy growth, and the plants lightly the spraying cover at a rate of 1 tool per second. upward into center of room with slow sweeping exposed food and utensils.

OUTDOORS: Spray area infested with these flying spray when temperature exceeds 90°F. Insects. Hold container 18-24 inches from shrubs. bushes and grassy areas. Spray these areas with a slow sweeping motion at a rate of 1 to 3 seconds per cubic yard of space while moving away from the treated area. To reduce annoyance from these pests treat open porches and patio in a similar manner. Spray only when the air is still. Allow spray to dissipate before occupying the treated area.

To Kill Ants, Centipedes Cockroaches, Crickets, Firebrate, Sowbugs and Spidera: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary. To Kill Carpet Beetles: Directly spray as many insects as possible. Spray both interior and exterior of uphoistered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture, and wherever these insects are seen or suspected. Repeat as necessary.

To Kill Exposed Forms of Confused Flour Beetles, Rice Weevils, and Saw-Toothed Grain Beetles: Find and destroy infested packaged goods. Remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on shelves, and return packages after shelves have dried. Repeat as necessary.

To Kill Fleas and Ticks in Pet Bedding and Pet Areas: Remove and destroy pet's old bedding. To reduce intestation, thoroughly spray the animal's bedding, sleeping quarters, around baseboards, window and door frames, wall cracks, local areas of floors, and other resting places until the surface is slightly moist Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also spray the entire inside surface of dog houses. Repeat as necessary. Put fresh bedding in pet's quarters after spray has dried. DO NOT SPRAY ANIMALS. Also treat dogs and cats with a registered flea and tick control product before allowing them to reenter treated area.

To Treat Flee and Tick Infestation in Rugs and Carpets: Spray rugs and carpets where fleas lend to hide. If used on light or delicate upholstery fabrics, test for potential staining in an inconspicuous place prior to use. Spray thoroughly into hiding places such as cracks and crevices, in walls and floors, along baseboards, window and door frames. Spray at the rate of one square foot per second. Repeat as
