Aim valve opening at the nest and depress button, continuing to spray until the nest is soaked with the spray. Push button completely down to release stream. Repeat as necessary

FOR CONTROL OF WASPS AND HORNETS; It is preferable to apply this product in the evening after all the insects have returned to the nest.

PRECAUTIONARY STATEMENTS


