d. Change the leading "Statement of Practical Treatment" to First Aid and revise the first aid statements below in accordance with PR Notice 2000-3. You may delete the statements for "If swallowed" "If inhaled" and "If in Eyes" since they fall under Toxicity Category IV.

e. Following the second sentence under directions for control of wasps, yellow jackets and hornets add "Treated insects will fall out of the nest and die. Wait 48 hours before removing the nest."

f. Delete the words "Foraging Red Imported Fire Ants" from the directions for ant control. This claim does not appear on the cited label nor does MGK identify data in support of this claim in their November 1, 1998 authorization letter for use of data in support of this product.

g. Replace the first six sentences beneath "Hazards to Humans and Domestic Animals" with the following: "Harmful if absorbed through skin. Avoid contact with eyes, skin or clothing. Wash hands before drinking, chewing gum, using tobacco or using the toilet."

h. Expand the directions for ants and spiders by adding where these pests can be found i.e., "For control of ants and spiders found in areas such as along house foundation, foundation vents sills and ledges. Spray in short bursts to contact pests."

3. Submit (2) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

DIRECTIONS

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Remove protective cap. Hold dispenser upright with valve away from face. Push button completely down to release stream.

FOR CONTROL OF WASPS, YELLOW JACKETS, AND HORNETS: It is preferable to apply this product in the evening after all the insects have returned to the nest. Aim valve opening at the nest and depress button, continuing to spray until the nest is saturated. Repeat as necessary. Foliage of desirable plants contacted during spraying should be hosed off with water.

FOR CONTROL OF FORAGING RED IMPORTED FIRE ANTS, ANTS, AND SPIDERS:
(Outdoor only.) Spray in short bursts to contact pests.
