

## Continued

POTATO - CUT SEED: Fusarium Seed Piece Decay, Black Leg, Seed-borne Common Scab - Apply 1 to  $1^{i_2}$  pounds of Seed Treater to each 100 pounds of seed pieces. For effective control, Seed Treater must be applied to entire surface of each piece immediately after cutting. If planting is delayed, follow the recommended storage practices of cut seed pieces in your area.

POTATO - WHOLE SEED: Seed-borne Common Scab - Apply 1 to 1½ pounds of Seed Treater to each 100 pounds of seed. Seed Treater should be applied evenly will be necessary if Black Leg and Fusarium Seed Piece Decay are to be

- 1. In the Environmental Hazard Statement, change "Keep...ponds" to "Do not apply directly to water. \*
- 2. Revise the Storage and Disposal Statement per enclosure or you may comply with PR Notice 83-3 which you should have received.
- 3. Add the following statement to the Directions for Use:

Treated Potato Seed-Pieces must not be used for or mixed with food or animal feed. Treat only those pieces needed for immediate use, minimizing the interval between treatment and planting. Do not store excess treated pieces beyond planting time.

A stamped copy of the label is enclosed for your records.
