#### APPLICATION DIRECTIONS

Western Farm Service GRANULAR SIMAZINE 2.0-U Herbicide is prepared for use as a dry, granular herbicide for the selective control of weedy plants as described below. In addition to this use, however, this product will provide the crop with the fertilizer value described in the guaranteed analysis. The effect of this product may be slow to appear and will not become apparent until the active ingredient is washed into the root zone of the weeds by rainfall or irrigation. The degree and duration of control will tend to vary with the amount applied, soil types, rainfall or irrigation and other environmental conditions.

SELECTIVE WEED CONTROL IN AVOCADOS, GRAPEFRUIT, LEMONS AND ORANGES – CALIFORNIA (except Palo Verde, Imperial and Coachella Valleys): To control annual weed seedlings such as Foxtail, Lambsquarter, Pigweed, and Wild Mustard, use 200 lbs. per acre as a broadcast treatment shortly after grove has been laid up in final form (non-tillage program) in late fall or early winter prior to or immediately following weed seed germination but prior to weed emergence. The dosage is given in pounds per treated acre. Broadcast uniformly to floor of orchard. May be applied by power driven ground or hand operated spreaders.

Avoid picking fruit for 10 days.

Do not apply in home plantings of citrus or in areas where the roots of other valuable plants or trees may extend.

**IMPORTANT:** Avoid direct contact with foliage or fruit. Do not apply to trees that have been subjected to freezing within 1 year. Do not use on course soils (sand or gravelly) nor where organic matter is less than 1% as injury may result. Use only after orchard has been established at least 1 year.

Do not use in nurseries. Make only 1 application per year.
