

DIRECTIONS FOR USE

GRAPES: For Powdery Mildew apply 10 to 30 lbs. per acre when shoots are 6 inches long — repeat periodically.

For Powdery Mildew and Grape Leaffolder apply 30 lbs. per acre. For Grape Leaffolder apply as soon as possible after egg hatch and before larvae are protected by leaf folds. Do not allow workers to enter treated areas within 1 day (24 hours) of application to engage in any activity requiring substantial contact with treated foliage. NOTE: Concord and other lubrusca type grapes may be injured.

MELONS: For Powdery Mildew apply 15 to 30 lbs. per acre. For Powdery Mildew and Cabbage Looper, apply 30 lbs. per acre. Begin when first true leaves appear and repeat at weekly intervals. DO NOT use within 2 weeks of an oil spray treatment.

NOTE: Certain varieties of Melons are susceptible to Sulfur damage.
