Do not get in eyes, on skin, or on clothing. Avoid contact with skin. Avoid breathing dust. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash before reuse".

e. In the Storage and Disposal section, revise the subheading "Storage" to read "Pesticide Storage".


f. Submit two (2) copies of the revised final printed label for the records.
