The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Fosetyl-Al Interim Decision, and has concluded that your submission is acceptable. The agency also completed review of your amended label referred to above, submitted in connection with registration under FIFRA, as amended, and has determined the label is also acceptable.
