After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

- (2) Terrestrial, Nonfood Crop (nonresidential): Christmas Tree Plantations; Outdoor Production Ornamentals in Nurseries (container and field-grown non-food foliage plants, flowers, non-bearing trees and vines);
- (3) Greenhouse, Nonfood Crop (nonresidential, including Saran and Shade Houses): Floriculture and Ornamentals;
- (4) All other uses for which the USEPA has approved the required data and/or citations of data that the formulator has submitted in support of registration; and

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling or reconditioning if available, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or a mix tank or collect rinsate at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Once container is rinsed, offer for recycling if available, or puncture and dispose of in a sanitary landfill.
