#### DIRECTIONS

A. Jirdon Lawn Fertilizer Containing Dacthal(R) Herbicide added to control Crabgrass and the following weeds in turf and ornamental plantings.

> Chickweed, Common Fall Panicum Carpetweed Lovegrass Sandbur Green Foxtail

Crabgrass, Lorge Lambsquarters Purslane Witchgrass Yellow Foxtail Crabgrass, Smooth

DO NOT USE on the following plants:

Bugleweed Button Pink Carnation Ceum Germander

Mesembryanthemum Pansy Phlox. Sweet William

Telanthera

- B. Apply as an early preventive treatment before germination of Crabgrass or other weed seed. Crabgrass seed germination usually coincides with the time that Forsythia blossoms start to fall. Make application on a calm day to avoid drift. In areas which commonly experience stands of late germinating Crabgrass and other annual weedy grasses, a second application a; one-half the regular rate can be safely made and is recommended two months after the first application.
- C. APPLY TO ESTABLISHED LAWNS ONLY. Apply twenty (20) pounds per 1,000 square feet. Apply evenly with a spreader. The use of Jirdon Lawn Fertilizer Containing Dacthal (R) Merbicide on Bentgrass turf should be restricted to areas previously known to be infested with Crabgrass and only to Bentgrasses where experience has shown applications to be safe. DO NOT APPLY TO DICHONDRA LAWNS.

Where reseeding is necessary, there should be a delay of approximately sixty (60) days after application.

- D. Before making application, lawn should be raked to remove extraneous material and insure uniform application.
- E. Do not rake lawn or disturb soil surface after application. Water-in lightly if no rain falls within a week aftr application. FERTILIZER CAN CAUSE STAINING TO DRIVEWAYS, SIDEWALKS, OR STONES. Area should be swept thoroughly before water is applied.
- F. Do not apply to Cohansy or Toronto Bents.
- G. SPREADER SETTINGS FOR SINCLE APPLICATION (One Direction):

Twenty (20) pounds per 1,000 square feet. Cyclone Model B ..... Scotts Model 35 and 17 ..... 11.5

### STORACE AND DISPOSAL
