1. The Keep Out of Reach of Children statement must appear before the signal word, as follows:

KEEP OUT OF REACH OF CHILDREN

### CAUTION

- We have noted that the Physical or Chemical Hazards section wording is in compliance with PR Notice 87~8. Since PR Notice 87-8 was withdrawn by PP Notice 87~11, you may wish to retain the Physical or Chemical Hazards label wording from your February 8, 1982 accepted label.
- 3. The portion of your label which contains the section that reads "CAUTION: Do not use in nurseries . . " should be included under the HAZARUS TO HUMANS AND DOMESTIC ANAMALS heading.
- 4. Add the following statement to the HAZARDS TO HUMANS AND DOMESTIC ANIMALS portion of the label "Harmful if swallowed. Avoid breathing spray mist."
- 5. The statement which reads "Food, food contact surfaces and utensils should be protected from exposure to the spray or washed with an effective cleaning compound before reuse" should be

6. The Storage and Disposal portion of the label must also contain the following statements:

Do not contaminate water, food or feed by storage or disposal,

PESTICIDE DISPOSAL - Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

7. Add the following section to the label:

### ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by disposal of waste.

8. Your Confidential Statement of Pormula (CSF) needs to be updated on the current form to reflect upper and lower certified limits. Enclosed is an updated CSF form for your convenience.
