DIRECTIONS FOR USE:

To kill Houseflies, Mosquitoes, Flying Moths and gnats: Close all doors and windows. Determine the amount of cubic space to be treated. Point nozzle upward and direct the aerosol mist to insects, walls, cross beams, under sides of pallets, over and around stacked goods, into empty bins and corners to effect thorough coverage of all surfaces. Repeat applications as necessary. Fog particularly well in areas where these insects are most likely to congregate or rest. Fog at the rate of 3 cartridges per 1000 cubic feet of space.

Keep the treated area closed if possible for 15 minutes. After treatment, air out thoroughly and close up and remove curtains.

In industrial locations, do not spray closer than 36 inches away from fabrics or upholstery. Spraying closer than as directed above or excessive treatment may cause damage.

Do Not Remain in Treated Area.
