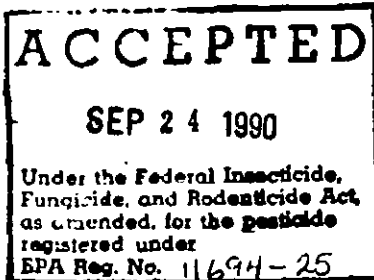

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Do not induce vomiting except under the direction of a physician. Get immediate emergency medical attention.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For control of wasps and hornets: Apply after dark when all the insects have returned to the nest. Aim valve opening at nest and depress button, soaking the nest with the spray. Repeat as necessary. Avoid wetting vegetation with this spray, as it will be damaged. Do not use as a space spray. Other uses-outdoor only: For control of ants, clover mites, crickets, earwigs, fleas, millipedes, sowbugs and brown dog ticks. Spray infested areas thoroughly including outside surfaces of screen frames, doors, window frames, foundations, patios or other places where insects may enter or harbor. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation. Do not use as a space spray.

STORAGE AND DISPOSAL

Storage: Contents under pressure. Do not store near fire, sparks or flame. Do not puncture or incinerate container. Exposure to temperatures above 120° may cause bursting.

Pesticide Disposal: Do not contaminate water, food or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Do not re-use the empty container. Wrap and discard in trash.

General: Consult federal, state or local disposal authorities for approved alternative procedures.
