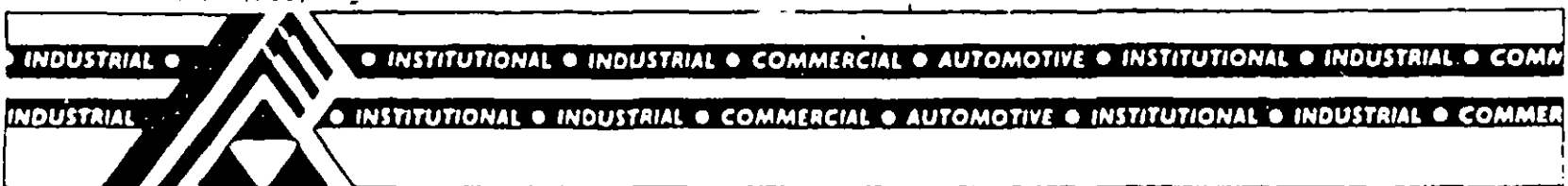

**STATEMENT OF PRACTICAL TREATMENT**

If swallowed: Do not induce vomiting. Contact physician immediately.  
 If on skin: Wash thoroughly with soap and water. If irritation persists,  
 consult a physician. If in eyes: Immediately irrigate with plenty of  
 water. Contact a physician.

This formulation gives rapid control of insects listed below including those resistant to certain chlorinated hydrocarbon and phosphate insecticides. Spray residues kill insects after the spray deposit has dried.

**DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

**General:** Spray surfaces to wetting. Point spray away from people, plants and pets.

**Indoor Use:** Ants, cockroaches, crickets, silverfish, spiders, scorpions, waterbugs: Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste container. Repeat as needed. Do not spray foodstuffs or plants. For ants, spray trails and places where ants enter premises. Do not allow anyone into treated areas until completely dry. Brown Dog Ticks: Spray sleeping quarters of dogs around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

**Outdoor Use:** Ants, clover mites, crickets, earwigs, fleas, millipedes and brown dog ticks: Spray infested areas thoroughly, including outside surfaces of screens, doors, window frames, foundation, patios or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

**CAUTION**

Keep out of reach of children. May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes or clothing should also be avoided. Wash thoroughly with soap and warm water after handling. Avoid contamination of food, utensils and food preparation areas. Remove animals and cover fish bowls before spraying. If poisoning occurs, get prompt medical aid. To Physician: Atropine sulfate is antidotal.
