**DIRECTIONS FOR USE**

**GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**SHAKE WELL BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.**

**To Kill Flies, Mosquitoes, Small Flying Moths and Gnats:** Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

**To Kill Cockroaches, Ants and Crickets:** Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

**To Kill Carpet Beetles:** Directly spray as many insects as possible. Spray interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

**To Kill Exposed Forms of Confused Flour Beetles, Saw-toothed Grain Beetles, and Rice Weevils:** Find and destroy infested package goods. Remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

**To Kill Sowbugs, Centipedes, Fire Brats and Spiders:** Contact as many insects as possible with the spray. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden surfaces under sinks, behind stoves and refrigerators.

**To Kill Fleas and Brown Dog Ticks:** Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboard, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Do not spray animals. Put fresh bedding in pets quarters after spray has dried. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area.

**STORAGE AND DISPOSAL**

**Storage:** Do not store in extreme heat or cold. Store in a dry location in an upright position away from ignition sources. Store away from other pesticides, fertilizers, food, feed and water.

**Disposal:** Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Consult local, state, or federal disposal authorities for approved alternative procedures.

**Container Disposal:** Replace cap and discard empty containers in trash unless prohibited by local ordinances. Do not incinerate or puncture.
