DIRECTIONS FOR USE

SHAKE BEFORE USING AND AT INTERVALS DURING PROLONGED USE.

Hold container upright with nozzle away from you. Press valve down and spray as directed. To avoid possible staining of fabrics or surfaces, do not spray at close range.

{(Flies, Mosquitoes, Gnats, Midges, Wasps, Hornets and Flying Moths(Millers))}: Close all doors and windows and spray room at a rate of 1 second per 1000 cubic feet. Direct spray to all parts of room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Keep room closed for 10 to 15 minutes after treatment. Repeat treatment as necessary.

PRECAUTIONARY STATEMENTS

Hazards To Humans & Domestic Animals

CAUTION Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water.
