APPLICATION

WEST-CIDE 760 is used to control algae in swimming pools. It is effective against free-floating varieties of algae as well as those varieties which cling to the walls and bottoms of pools. Regular use of WEST-CIDE 760 in swimming pools can overcome problems caused by algae including unsightly appearance, murky water, objectionable odors, clogged filters and increased chlorine demand. WEST-CIDE 760 will not cause foam.

For maximum effectiveness, pools containing a heavy growth of algae should be cleaned prior to using WEST-CIDE 760.

For pools having just visible algae growth, add an initial dose of 89 to 140 fluid ounces of WEST-CIDE 760 for each 10,000 U.S. gallons of water.

For treatment of freshly cleaned and filled pool, add 48 to 89 fluid ounces of WEST-CIDE 760 for each 10,000 U.S. gallons of water. To maintain pools free of visible algae, add 15 to 30 fluid ounces for each 10,000 U.S. gallons every 5 to 7 days after initial treatment.

Apply at a point in the pool system where WEST-CIDE 760 will be uniformly mixed.

CAUTION
