**DIRECTIONS FOR USE  
GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Westcide 959 is used in swimming pools, exterior spas, whirlpools, hot tubs, and indoor effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial fluid ounces of Westcide 959 per 10,000 gallons of water. For treatment of a pool add initially 27 to 50 fluid ounces of Westcide 959 per 10,000 gallons of water. Subsequent additions of Westcide 959 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 5 to 8 fluid ounces per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 3 fluid ounces of Westcide 959 per 1,000 gallons of water.

Subsequent additions of Westcide 959 should be made every 5 to 7 days after initial treatment.

Westcide 959 is compatible with concentrated dry or liquid chlorine products used to treat pools, spas, and decorative fountains and should be used at an alkaline pH. Westcide 959 can be used on decorative fountains treated with chlorine chemicals and chemicals normally required. However, do not mix Westcide 959 with concentrated dry or liquid chlorine products.

**STORAGE AND DISPOSAL**

**STORAGE:** Keep container closed when not in use. Containers should be placed in a plastic bag and discarded with clear water. All pesticides should be kept out of reach of children and away from food.

**DISPOSAL:** Do not reuse empty container. Wrap container in plastic and discard.
