DIRECTIONS FOR USE
GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Westcide 960

is used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial fluid ounces of Westcide 960 per 10,000 gallons of water. To move settled algae debris by cleaning. For treatment of a pool add initially 12.8 to 23.5 fluid ounces of Westcide 960 per 10,000 gallons of water. Subsequent additions of Westcide 960 per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 2 to 4 fluid ounces per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 1 fluid ounce of Westcide 960 per 1,000 gallons of water. Subsequent additions of Westcide 960 should be made every 5 to 7 days after initial treatment.

Westcide 960 is compatible with chlorine products used to treat pools, spas, and decorative fountains and should be used with an alkaline pH. Westcide 960 can be used on decorative fountains treated with chlorine chemicals and chemicals normally required. However, do not mix Westcide 960 with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of the home and away from food.

DISPOSAL: Do not reuse empty container. Wrap for disposal.
