

WARNING: Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Al Chem 109 is used to control algae in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, microbial deposits, and other deposits. An initial slug addition of 3.3 to Al Chem 109 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to 6.6 Al Chem 109 per 1000 gallons of water every 1 to 5 days, or as needed. The frequency of addition should be determined relative to the amount of bleedoff and the severity of the microbial growth. Additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in original container. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums for transport. Do not be absorbed in sawdust or sand and disposed of in a sanitary landfill. Container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. Wastes cannot be disposed of by use according to label instructions.
