

FOR USE ON CATTLE, HORSES, SHEEP, GOATS AND SWINE: Hold container about 3 inches from wound or infested area. Be sure opening is directed toward area to be treated. Press valve down to spray. Wet thoroughly by spraying directly into and about 1 inch around wound.
