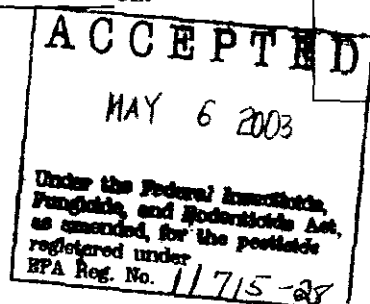

FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL

Remove protective cap and aim spray opening away from person. Push button to spray.

ANIMAL PESTS

FLEAS: Apply directly to animals along back, under forelegs and on other areas. Part hair to contact skin and insure good coverage. Hold nozzle about one foot away while spraying. Apply until hair is thoroughly moist. Do not spray in eyes, ears, or mouth of animal.

ANIMAL QUARTERS

To reduce reinfestation, thoroughly spray the animal's bedding and other resting places. Treat these areas at the rate of two seconds per linear foot while spraying at a distance of 12 to 18 inches. Also spray entire inside surface of dog houses.

Do not reapply product for 7 days. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool area away from heat or open flame.

DISPOSAL: Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
