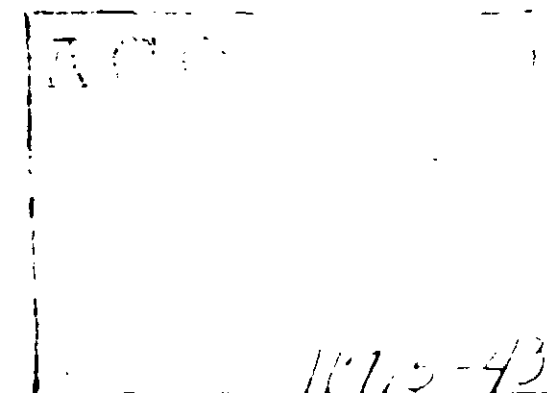

DIRECTIONS FOR USE

Use one canister for each 5,000 cu. ft. of unobstructed area. Example:
25' long X 20' wide X 10' high = 5,000 cu. ft. Use additional units
for remote rooms or where free flow of mist is not assured.

PREPARATION: Remove any insect-proofing debris. Cover exposed
food, utensils and food handling surfaces. Open cabinets and
doors to areas to be treated. Shut off fans and air conditioners.
Put out all open flames except pilot light. Remove pets,
birds, and cover fish aquariums before spraying. Close exterior doors
and windows.

Cover exposed foods, dishes, and food handling equipment.

TO START FOGGING: Place Fogger on table, chair or stand, at least six
feet from pilot. Place several thicknesses of newspapers under canister
to prevent marring of surface. Hold can at arm's length, with top of can
pointing away from face and eyes. Push on arrow (on smaller side of plastic
actuator) until plastic clip catches on edge of canister lip-- this will
start fogging action. Set canister in upright position on table, etc.
and leave building a once. DO NOT RE-ENTER BUILDING FOR TWO HOURS,
then open exterior doors and windows and allow to air for 30 minutes
before reoccupying area.

CAUTION

KEEP OUT OF REACH OF CHILDREN
