#### DIRECTIONS

INDOOR-FOR PROTECTION OF WOOLENS GARMENTS, BLANKETS, DRAPES: Apply only to garments, blankets, carpets and other woolen fabrics before placing in storage- for protection from larvae webbing clothing moths and black carpet beetles.

Dry clean or wash garments and blankets before testing. Clean carpets, draperies and other fabrics by thoroughly brushing before treating.

SHAKE WELL BEFORE USING. Hold container upright 14 to 18 inches from fabric. Point nozzle away from you and apply the spray while moving evenly in a forward and back motion across the fabric, covering one foot per second.
