The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. A stamped copy is enclosed for your records.

As new labels are prepared, delete the term "related compounds" and "other isomers" from the label ingredient declaration. Unless otherwise substantiated, these isomers should be considered inert. If the "related compounds", etc. are determined to be active, they should be incorporated in the declaration for the active ingredient and not distinguished as "related compounds" or "other isomers".

In accordance with the Sumithrin Registration Standard, change the label declaration for sumithrin to read: "3-phenoxybenzyl-(1RS, 3RS; 1RS, 3SR)-2,2-dimethyl-3-(2-methylprop-1-enyl)cyclopropanecarboxylate. Also, delete the term "allyl homolog of cinerin I", since this is an inaccurate description of the d-trans allethrin isomer.

#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use one canister for each 6,000 cu. ft. of unobstructed area. Example 30'long x 20'wide x 10'high = 6,000 cu. ft. Use additional units for remote rooms or where free flow of mist is not assured.

Preparation: Cover exposed foods, dishes, and food handling equipment. Open cabinets and doors to areas to be treated. Shut off fans and air conditioners. Put out all open flames except pilot light. Remove pets and cover fish tanks or fish bowls with paper, or remove from area. Close exterior doors and windows.

To Start Fogging: Place fogger on table, chair, or stand, at least six feet from pilot light. Place several thicknesses of newspapers under canister to prevent marring of surface. Hold can at arm's length, with top of can pointing away from face and eyes. Push down on finger pad until it locks- this will start fogging action.

Set canister in upr building at once. FOR FOUR HOL windows and allow cupying area.
