SPIDERS: Spot treat areas where these pests are found or may hide, including dark corners of rooms contaminated eyes with plenty of water and get and closets, cracks and crevices in walls, along baseboards and door and window frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

BROWN DOG TICKS: To control these pests. thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old pet bedding should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.

FLIES AND MOSQUITOS: Use only out-ofdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door · frames as well as other areas where these pests may

enter the home.
